Dear Dr. Siddiqui:

Your Cellulose Spray Applied Insulation was tested by our laboratory to determine its emissions of toxic volatile organic chemicals (VOCs) of concern. The test was conducted following the procedures described in Section 01350 of the Material Specifications adopted by the Collaborative for High Performance Schools (CHPS).

Calculations were performed using the parameters given below for a standard classroom to estimate the concentrations of VOCs of concern resulting from the use of your product in a classroom environment. The product was modeled as a wall material. The results of the test and the calculated concentrations for the standard classroom are presented in our attached report, EMIT1166, 8/31/04.

Page 5, Equations Used in Calculations, Comments

Calculations - An emission factor (EF) in µg m⁻² h⁻¹ for a chamber test is calculated using Equation 1:

$$EF = (Q (C - C_0)) / A_C$$

where C is the VOC chamber concentration ($\mu g \ m^{-3}$) and C_0 is the substrate or chamber blank VOC concentration ($\mu g \ m^{-3}$). The remaining parameters are defined in Table 2. A building concentration (C_B) in $\mu g \ m^{-3}$ is calculated using Equation 2, and parameters are defined in Table 3.

Comments: All six sides of specimen were exposed during test. Calculation was based on one face area of sample.
